

The European GMO-free Regions Network was born as a response to the European Commission Recommendation of July 2003 on Guidelines for the development of national strategies and best practices to ensure the coexistence of genetically modified crops with conventional and organic farming.

In order to draw up this Recommendation, the Commission took into account that farm and field sizes, production systems, crop rotations and cropping patterns, as well as natural and climatic conditions vary enormously across Europe. Therefore, the Commission admitted that these different regional aspects should be taken into account when applying the precautionary principle, or in other words, when evaluating on a "case by case" basis the risk of admixture between GM and non-GM crops. However, although the Commission states that certain strategies only make sense at a regional level, in practice nowadays the European legal framework allows neither for a regional implementation of that authority nor for the full freedom of choice in a situation of coexistence between GM and non-GM crops.

Since its creation the Network has held five conferences in which various subjects have been considered, but all of them have dealt with the regions' claim to have a regional scale decision-making on coexistence.

Throughout this last year a series of relevant Network events and activities have taken place. For example, in December 2007 we held our conference on non-genetically modified feed and, more recently, we had the German Parliament's decision to authorise the labelling of products as OGM-free.

These actions are fully consistent with the principles that inspired the creation of our regional network – namely, to assure the absence of genetic contamination from crops and to guarantee regions' freedom of choice in what to cultivate.

The VIth Conference will deal with these two fundamental subjects in order to put forward future actions that will continue in the same direction, and in particular to encourage the agro-food industry to use the OGM-free labelling.

Also, as a network of regions that have chosen a model of agriculture based on quality, it is the appropriate time to reflect on the insertion of our regional policies in the framework of the post "health-check" Common Agricultural Policy (COM (2007) 722 final).
